FRAMEWORK FOR OUR FUTURE: A COLLABORATIVE, DATA-DRIVEN, AND EQUITABLE RESPONSE TO COVID-19 IN SAN DIEGO COUNTY (DISTRICTS: ALL)

OVERVIEW

On February 14, 2020, the San Diego County Public Health Officer issued a Declaration of Local Health Emergency, in response to the COVID-19 pandemic, one of the first counties in the nation to take such a bold action. On March 19, 2020, the State of California public health officials issued an order for anyone living in the state to stay home, except for those providing essential services.

While the San Diego County Public Health Officer has been leading the response in San Diego County in a data-driven manner, in the months since the initial stay at home order in March 2020, this Board has undertaken various activities in opposition to the COVID-19 response. The previous Board has questioned the actions of San Diego County's Public Health Officer; written letters to the Governor in opposition of Executive Orders; and some Board members have openly advocated for the defiance of State and local Public Health orders. These actions have harmed our public health response and undermined confidence in our strategy.

COVID-19 has disproportionately impacted communities of color. Current county data shows that the case rates for minority populations are significantly higher than for their white counterparts. This disparity is especially pronounced in the Hispanic or Latino community. The same disparate impact is reflected by the data showing the distribution of cases by zip code, particularly the prevalence of cases in the South Bay and Southeastern San Diego. San Diego County has made great strides engaging with the community and determining new methods to improve outreach but focus and additional resources are required to continue to improve the scope of work.

Today's actions request the San Diego County Board of Supervisors adopt a resolution to reorient and restate our County's response to COVID-19; one that adheres to a continued, data-driven response; works collaboratively, rather than antagonistically with the State; and emphasizes a more

equitable response to the pandemic by prioritizing future funding using a health equity lens when appropriate.

RECOMMENDATION(S) SUPERVISOR NATHAN FLETCHER AND SUPERVISOR NORA VARGAS

- 1.) Adopt the attached resolution entitled A COLLABORATIVE, DATA-DRIVEN, AND EQUITABLE RESPONSE TO COVID-19 IN SAN DIEGO COUNTY, which outlines the science-based and equitable approach the County will pursue working in collaboration with State officials in response to the COVID-19 pandemic.
- 2.) Find that the policy statements contained in the attached resolution supersede any contradictory policy statement contained in past Board of Supervisors initiated resolutions and letters related to COVID-19.
- 3.) Direct the Chief Administrative Officer to prioritize, when appropriate, the distribution of future COVID-19 response and recovery-related federal, state, and local funding based on a data-driven approach that identifies communities requiring the highest need of support based on positive COVID-19 cases and takes into account health equity tools that measure degree of disparities.

FISCAL IMPACT

This action will not have any current fiscal impact but contemplates prioritizing with an equity lens, when appropriate, the distribution of future allocations of COVID-19 response and recovery-related federal, state, and local funding based on highest need.

BACKGROUND

On February 14, 2020, the San Diego County Public Health Officer issued a Declaration of Local Health Emergency, pursuant to California Health and Safety Code Section 101080 in response to the COVID-19 pandemic, one of the first counties in the nation to take such a bold action. By taking early action, the County signified our commitment to public health and preparation for the pandemic. On March 19, 2020, the State of California public health officials issued an order for anyone living in the state to stay home, except for those providing essential services.

Community transmission of COVID-19 in San Diego County remains a central concern of San Diego County's Public Health Department. The County made significant efforts early in the pandemic to "flatten the curve," slowing down the spread of the virus, which helped to avoid an increase in the cases that overwhelm the healthcare system. For this reason, the San Diego County

Public Health Officer continues to issue and amend Public Health Orders to enhance efforts to protect the health of the public. Despite early success, San Diego County has experienced recent surges in positive cases, often tied to people ignoring or openly defying safety measures. These actions are due in part to fatigue with the long-standing situation, but also can be attributed to the mixed messages from elected officials at all levels whose statements and actions are sometimes in direct contradiction to the Public Health Orders. This irresponsible behavior has been detrimental to our region's health and safety.

As of December 6, 2020, San Diego County, as part of the 11-county Southern California region and in response to the Intensive Care Unit (ICU) bed capacity dipping below 15 percent, was placed on a more restrictive stay at home order by the State of California. As a result of the ICU bed trigger, further restrictions on activities outside of essential ones were put in place to slow the spread of COVID-19 and ease the pressure on the region's hospital system.

As of January 2, 2021, in San Diego County, there have been 168,020 confirmed positive cases of COVID-19 and 1,592 deaths due to the virus. Hospitalized patients over the past 30 days have increased 93 percent and ICU patients over than same time have increased by 84 percent. The current capacity of the Southern California region ICU bed capacity is 0 percent.

COVID-19 has disproportionately impacted communities of color. Current county data shows that the case rates for these populations are significantly higher than for their white counterparts. This disparity is especially pronounced in the Hispanic or Latino community. As of January 2, 2021, 83,415 of COVID-19 cases, or 57.6 percent of the region's total, were individuals who identified as Hispanic or Latino, while according to estimates from the US Census, only 34.1 percent of the county's population is Hispanic or Latino. 12 That accounts for a rate of 7,629.1 per population of 100,000.3 Black San Diegans, as of January 2, 2021, account for 5,067 of San Diego COVID-19 cases, a case rate of 3,007.9 per 100,000.4 And while Native Hawaiian/Pacific Islander individuals account for only 1.0 percent of San Diego County's total COVID-19 cases, this equates to 9,765.8 cases per population of 100,000 for that ethnicity. As a comparison, San Diego County residents identifying as white have a rate of 2,429.5 population of 100,000.5

The same disparate impact is reflected by the data showing the distribution of cases by zip code, particularly the prevalence of cases in the South Bay and Southeastern San Diego.

At the same time, these zip codes tend to be the areas with the most negative economic impact due to the COVID-19 pandemic. One reason is that many in these communities work in tourism and service jobs, sectors that have been particularly hard hit by the economic outcomes of the COVID-19 pandemic. While professional and business service jobs have started experiencing growth (additional 2,800 jobs between October and November 2020), there continues to be job loss in the leisure and hospitality sectors (900 additional losses during that same time period). An October 2020 report by the San Diego Association of Governments (SANDAG) noted that half of the 64,800 individuals who experienced job loss in the first six months of COVID-19 and identified as Hispanic or Latino were employed in the tourism sector. This impact is reflected in particularly high unemployment numbers in the same zip codes that have been experiencing high numbers of positive cases of COVID-19. For example, according to a recent report on the impact of the pandemic on the San Diego economy, zip codes in Logan Heights, Golden Hill, City Heights, National City, and San Ysidro had some of the highest percentage of unemployment in the region (ranging from 17.6 percent - 14.7 percent).

The reasons for the disproportionate harmful impact of COVID-19 on communities of color are myriad and include: existing health disparities exacerbated by the pandemic and related to lack of equitable health access; absence of federal support of low-wage workers, leading to economic realities that required continuing in the workplace, even if situations are unsafe; higher likelihood of working in high-contact essential jobs that cannot be carried out remotely; prevalence of people of color in job sectors such as tourism and the service industry that have not yet made an economic recovery; and inequitable distribution of resources to those most impacted. San Diego County has made great strides engaging with the community and determining new methods to improve outreach but focus and additional resources are required to continue to improve this scope of work.

While the San Diego County Public Health Officer has been leading the response in San Diego County in a data-driven manner, in the months since the initial stay at home order in March 2020, the previous Board has undertaken various activities in opposition to the COVID-19 response. This Board has questioned the actions of San Diego County's Public Health Officer; written letters to the Governor in opposition of Executive Orders; and some Board members have openly advocated for the defiance of State Public Health orders. These actions have harmed our public health response and undermined confidence in our strategy.

Furthermore, the Board has allocated funding across the region, but the emphasis has been on equal distribution rather than equitable distribution. As such, the underlying inequities are made starker.

Today's actions request the San Diego County Board of Supervisors adopt a resolution to reorient and restate our County's response to COVID-19, one that adheres to a continued, data-driven

Further, given the disproportionate impacts on people of color and zip codes associated with lower incomes, future COVID-19 response and recovery funding received by the County should prioritize these hardest hit areas and populations using a health equity lens when appropriate.
